ع is transliterated as elevated inverted comma (').

ض as an Arabic letter is transliterated as (ḍ), and as a Persian/Turkish/Urdu letter as (ž).

و as an Arabic letter is transliterated as (w), and as a Persian/Turkish/Urdu letter is transliterated as (v).

ا is transliterated as (ah) in pause form and as (at) in construct form.

Article ال is transliterated as (al-) whether followed by a moon or a sun letter, however, in construct form it will be transliterated as ('l).

و as a Persian/Urdu conjunction is transliterated as (-o) whereas as an Arabic conjunction و is transliterated as (wa).

Short vowel (ـ) in Persian/Urdu possessive or adjectival form is transliterated as (-i).

INTRODUCTION

Al-Dirāsāt al-Islāmiyyah is a leading Pakistani refereed research journal published by the Islamic Research Institute (IRI) since 1965 in Arabic language. It is a quarterly journal dedicated to providing original research articles in Islamic Studies as well as analysis and commentary on issues related to Islam and Muslim *ummah*. This journal brings together many of today's distinguished scholars and thinkers, making their research and commentaries available not only to specialists but to a wider audience of readers in the Arabic language.

Al-Dirāsāt al-Islāmiyyah is an interdisciplinary journal of peer-reviewed research and informed opinion on various intellectual and academic issues in areas of Islamic Studies. Its readership includes scholars, practitioners, religious leaders, policymakers, journalists, and general readers. Intellectually rigorous yet accessible and practical, *al-Dirāsāt al-Islāmiyyah* provides an influential outlet for original scholarship in Islamic studies, social sciences, law, and humanities, as well as a lively forum for commentary on current issues from the Islamic perspective. Research articles published in this journal undergo initial editorial scrutiny, double-blind peer-review by at least two experts in the field, and further editorial review. Some past issues of this journal have been dedicated exclusively to particular themes.

Indexation of *al-Dirāsāt al-Islāmiyyah*

Al-Dirāsāt al-Islāmiyyah is recognized as one of the leading research journals of Islamic studies and its allied disciplines in the academic world. This research journal has set international academic standards for the last six decades. It was recognized by the Higher Education Commission (HEC) of Pakistan in the “X” category, vide Notification No. R&D (RJS)/HEC/816, dated: May 04, 2020, but according to the new policy of HEC, the journal is now considered in the “Y” Category. Moreover, it is indexed or abstracted by the following agencies:

1. The journal is abstracted in *al-Manhal*. Through this database, it is also enlisted in EDS (EBSCO Discovery Services) and SUMMON™ as they are partners of *al-Manhal*.
2. The journal is indexed by the Australian Islamic Library.
3. The journal is indexed by the Islamic Research Index, Allama Iqbal Open University (AIOU), Islamabad vide letter dated 26.01.2015.
4. Crossref DOI – Prefix is 10.52.241.
5. The journal is enlisted in the Ulrich Directory of Periodicals vide ID No. 32489.
6. The abstracting and indexation of *al-Dirāsāt al-Islāmiyyah* in ALTA (American Library of Theology Association) are under process.
7. The *EBSCOhost* is also considering the request of the Islamic Research Institute (IRI) to include *al-Dirāsāt al-Islāmiyyah* in its database.
8. The abstracting and indexation of *al-Dirāsāt al-Islāmiyyah* in Scopus and Web. of Science are under process.

GUIDELINES FOR CONTRIBUTORS

The Editorial Board requests the respected contributors to note/observe the following requirements:

1. An abstract written in English, ranging from 150 to 200 words, should be submitted along with the paper.
2. The paper submitted for publication must be original, unpublished, and must not be extracted from any published book/dissertation.
3. The paper must fulfil all the well-known standards of original academic research.
4. Citations must be provided in the continuous footnotes on the same page.
5. The paper should be composed in 12/14-point size in MS Word format. Papers in PDF are not accepted.
6. Citations should be following *al-Dirāsāt al-Islāmiyyah*'s prescribed format (i.e., author's name, book title, publisher, place and date of publication, vol. no., page no.).
(For example, S. M. Azizuddin Husain, *Structure of Politics under Aurangzeb 1658-1707*, Kanishka Publishers, New Delhi, 2002, p. 101).
7. A brief CV may be provided if an author submits a paper for the first time.
8. All papers undergo initial editorial scrutiny. Thereafter, these are sent to two experts in the field for their critical assessment. The Editorial Board, however, takes the final decision to publish a paper or otherwise and is not bound to explain the reasons for its decision.
9. The journal reserves the right to change, modify, or edit the papers before publishing them or request the writers to do so where it deems necessary.
10. The authors are immediately informed about the receipt of their papers by the journal. However, the decision to publish/reject the papers is communicated after the due process of evaluation is completed.
11. No paper should exceed fifty pages, nor should be less than twenty pages, each page having around 330 words.
12. Opinions expressed in the papers are the responsibility of the writers alone and do not represent the policy of the journal.

Submission of Manuscripts

Manuscripts are required to be submitted in MS Word files through the Open Journal System (OJS) at the following web link:

- **Articles** – Use the author and article title as they appear on the first page of the article (if not given in full there, then use the table of contents version). If the month is given in the journal, include it in this form: author, “title,” *journal*, vol. 22, no. 3 (March 2002): 74-76; if only the year is given, including the journal’s volume and number in this form: author, “title,” *journal*, vol. 22, no. 3 (2002): 74-76.
